FIAMM is supporting Team Fantic Racing at the 46th edition of the toughest rally in the world that started from Al Ula in Saudi Arabia on 5 January 2024. For fifteen days the riders will challenge themselves and the immensity of the desert.

Team Fantic Racing will prove that it can compete at the highest level with minimal environmental impact using only sustainable or renewable energy sources for a fortnight on 7,891 kilometres of trails, dunes and rocky crossings, without forgetting 4,727 kilometres of timed trials.

The brand gained international notoriety following the success of the Caballero in regularity rallies and three Trial World Championship titles. Fantic was acquired by VenetWork S.p.A. in 2014. The company is growing fast and the motorbike portfolio today includes 2-stroke and 4-stroke enduro, cross and motard models, from 50 to 450 cc, as well as the Caballero, which is available with 125 cc and 500 cc single-cylinder engines and 700 cc double-cylinder engine.
